

# CHAPTER I

## INTRODUCTION

This chapter explains the background of the study, the reasons for choosing the topic, the statement of the problem, the objective of the study, the hypothesis of the study, the limitation of the study, the significance of the study, the definition of key terms, and the organization of the study.

### **1.1. Background of the Study**

Learning English in Indonesia has been developed extensively because English is a worldwide language and it as a compulsory subject at schools. In learning English, vocabulary as one of the language elements which is reviewed as very important factor in increasing English besides lexical and grammar. Vocabulary is language learning element that has to be built and developed by native or non native speaker.

The advantages are it is easy to carry around, it is easier in finding a word, the sound is available, it has updated new words, and it has extra information on the database. ## **1.2. Reasons for Choosing the Topic**
