

## **RECONSTRUCTION OF REGULATION REQUIREMENTS FOR FORMATION AND EXPANSION OF NEW PROVINCE BASED JUSTICE VALUE**

### ***ABSTRACT***

The aspirations of proposals from the community of each region which will become the scope of the prospective new provincial area ; b. Decision of each regency / city DPRD which will be the scope of the area of the prospective province on the approval of the formation of provincial candidates based on the results of the Plenary Meeting; c. Decisions of regents / mayors are determined by joint decisions of regents / mayors of the province's prospective territories regarding approval for the formation of provincial candidates; d. Decision of the parent province DPRD regarding approval of the formation of provincial candidates based on the results of the Plenary Meeting; e. Decision of the governor regarding approval for the formation of provincial candidates; and f. Minister's recommendation . ## **REKONSTRUKSI REGULASI SYARAT PEMBENTUKAN DAN PEMEKARAN PROVINSI BARU BERBASIS NILAI KEADILAN**

### ***ABSTRACT***

Guna mewujudkan suatu pembentukan dan pemekaran wilayah khususnya wilayah provinsi, perlu dilakukan rekonstruksi. Setelah direkonstruksi Pasal 5 ayat (1) Peraturan Pemerintah Nomor 78 Tahun 2007 tentang Tata Cara Pembentukan, Penghapusan dan Penggabungan Daerah. Syarat administratif pembentukan daerah provinsi sebagaimana dimaksud dalam Pasal 4 ayat (1) meliputi: a. Adanya aspirasi usulan dari masyarakat masing-masing daerah yang akan menjadi cakupan calon wilayah provinsi baru; b. Keputusan masing-masing DPRD kabupaten/kota yang akan menjadi cakupan wilayah calon provinsi tentang persetujuan pembentukan calon provinsi berdasarkan hasil Rapat Paripurna; c. Keputusan bupati/walikota ditetapkan dengan keputusan bersama bupati/walikota wilayah calon provinsi tentang persetujuan pembentukan calon provinsi; d. Keputusan DPRD provinsi induk tentang persetujuan pembentukan calon provinsi berdasarkan hasil Rapat Paripurna; e. Keputusan gubernur tentang persetujuan pembentukan calon provinsi; dan f.
