Carl Jung says that Personality is the totality of all psychic things both conscious and unconscious. "The number of different systems but interacted each other". The most important systems are the ego, the personal unconscious as well as its complexities, the collective unconscious and its arcs, the persona, the shadow, the anima and the animus, and the self (Jung, 5-6). Jung also bases his personality theory on the assumption that the mind has a level of consciousness and unconsciousness. An important point of Jung's theory is personal unconsciousness. According to Jung, the shadow about the conscious is something that can be felt by the ego, while the unconscious element has nothing to do with the ego. Jung sees the ego as the center of consciousness, but is not the core of consciousness itself. Then personal unconscious includes all experiences that are forgotten, suppressed, or perceived sublimely to someone. Our personal unconscious is shaped by individual experience. Thus, it will be very unique to people. There is a personal unconscious picture that can be easily remembered or difficult, but there are also some parts that are far from the reach of human consciousness. Then, the collective unconscious does not refer to ideas that are derived, but rather to the strong tendency of humans to react in certain ways at the time of their experiences (Jung, 4). Jung also has Archetype, that are images of the past and even archives that originate from the collective unconscious. Archetypes are more common and originate from the collective unconscious content. Archetypes must be distinguished from instincts (Jung, 4). Jung defines instincts as physical unconscious impulses for action, whereas he sees archetypes as a rival instinct because they are psychic. Both archetypes and instincts are unconscious and both can help shape personality. Archetypes that's have own life and personality. The most recognizable archetypes include persona, shadow, anima, animus, and self. However here I will focus on persona and shadow.

Persona is the side of personality that is shown to the world. The term persona is taken from the mask used by theater actors when playing a role. Carl Jung believes that every human being is involved in certain roles that are demanded by the social. Also persona is the psychic part where they are known as other people; persona protected the ego from negative images, and can appear in dreams in many different forms. When people get too close to persona, it will build an unconscious about individuality, and it will be difficult in the process of achieving self-realization. To be psychologically healthy, people need to be balanced between social expectations and what people personalities really is (Jung, 6-7).

Shadow is a type of archetypes of darkness and repression that represent qualities that do not want to be recognized and people try to hide them from themselves and others. Jung said that people must know how we fight this shadow. It is easier for us to project the bad of our personality to others, which people refuse to see in themselves. People are not aware of their shadows but people are more often aware of the good side of their personality. People who have never noticed his shadow, according to Jung, are people who have tragic lives and are not brave. Shadow personality is hidden from vision and only appears in certain circumstances. Other people don't know this person more or less (Jung, 6).

From the background of the study, the study chooses this movie as the research because it provides the problem about personality of persona and shadow based on story in *Sierra Burgess is a loser* movie. The reason I took this movies research is because this movie is very interesting and because this movie is related topsychology personality and teenage behavior that must be known.
