# **CHAPTER 1**

# **INTRODUCTION**

## A. Background of the study

Literature is an expression of human expression in the form of written or oral works based on thoughts, opinions, experiences, to feelings in an imaginative form, a reflection of reality or original data wrapped in aesthetic packaging through language media. The above understanding is reinforced by Sumardjo & Saini (qtd. in Thabroni 1997: 3) which argues that Literature is an expression of the human person in the form of experiences, thoughts, feelings, ideas, enthusiasm, beliefs in a form of concrete images that evoke enchantment with language tools.

Literature has diverse functions in human life. Amir (2010) revealed that several literary functions, namely the functions of entertainment, education, beauty, morals, and religious. This work not only gives a happy feeling to the reader, but also provides education through the extrinsic values contained therein. According to Eagleton;

Literature is a work of beautiful writing (belle letters) which records something in the form of a language that is condensed, inserted, twisted, lengthened and twisted, turned

into odd or other aesthetic changes through language tools (qtd. in Thabroni, 2010: 4).

The film is a literary work that is included in the type of drama that is a story that uses dialogue as the main ingredient to convey the story and various events in a story. Made in the form of a script and then acted in a theater performance or transformed into a film. In this study the author uses film as research material, the author uses the film *The Pursuit of Happyness* by Gabriele Muccon because the writer wants to discuss life, habits and characteristics that are reflected in the values of life on the main character Chris Gardner who is mentioned in American Ethos.
