Bahasa sebagai media komunikasi yang mempunyai peran penting untuk melakukan proses berinteraksi, dalam berinteraksi tentunya mempunyai tujuan tuturan guna menghasilkan sesuatu yang ingin dicapai oleh penutur. Melihat pentingnya peran bahasa didalam sebuah interaksi dikehidupan manusia, untuk itu kita perlu memahami tindak tutur agar kita berhasil dalam mencapai tujuan tuturan. Penelitian ini fokus pada tindak tutur ilokusi dan perlokusi karena dalam kedua tindak tutur tersebut terdapat sebuah tindakan ataupun hasil dari tuturan yang diujarkan. Pemilihan novel Dua Garis Biru Karya Gina S.Noer dalam penelitian ini karena novel tersebut merupakan cerita seks edukasi, tentunya cerita edukasi seksual perlu diperkenalkan kepada para pembaca, karena banyak pembelajaran positif yang dapat diambil. Data penelitian ini diambil dari kutipan dialog para pemain novel Dua Garis Biru. Pemilihan metode penelitian ini adalah metode deskriptif kualitatif, teknik simak dan dilanjut dengan teknik catat sebagai teknik pengumpulan datanya. Hasil penelitian ditemukan data sebanyak 64 data jenis tindak tutur ilokusi, yang meliputi 16 data representatif, 32 data direktif, 15 data ekspresif, 7 data komisif, dan 6 data deklaratif. Sedangkan, jenis tindak tutur perlokusi ditemukan sebanyak 22 data, yang meliputi 14 data perlokusi respon positif, 9 data perlokusi respon negatif, dan 6 data perlokusi nonresponsif.

Language as a communication medium that has an important role to do the process of interacting, in interacting certainly has the purpose of speech in order to produce something that the speaker wants to achieve. Seeing the importance of the role of language in an interaction in human life, for that we need to understand speech acts so that we succeed in achieving the purpose of speech. This research focuses on illocutionary acts and perlocutionary acts because in both speech acts there is an action or the results of the utterances spoken. The selection of the novel Dua Garis Biru by Gina S.Noer in this study because the novel is an educational sex story, of course the sexual education story needs to be introduced to the readers, because there is a lot of positive learning that can be taken. The data of this study were taken from dialogue quotations from the players of the Two Blue Line novels. The selection of this research method is a qualitative descriptive method, refer to the technique and continued with the note taking technique as a data collection technique. The results found 64 data types of speech acts of illocutionary acts, which included 16 representative data, 32 directive data, 15 expressive data, 7 commissive data, and 6 declarative data. Meanwhile, the types of speech acts of perlocution were found as many as 22 data, which included 14 data of the response of positive response, 9 of data of response of negative response, and 6 data of non-responsive perlocution.
