

TRANSPARANSI PENGELOLAAN ALOKASI DANA DESA (ADD) UNTUK MEWUJUDKAN GOOD GOVERNANCE

(Studi Kasus Desa Kalisari Kecamatan Blado Kabupaten Batang)

ABSTRAK

Penelitian ini dilakukan terkait dengan pengelolaan Alokasi Dana Desa dan APBDesa berdasarkan hasil riset/penelitian di Desa Kalisari Kecamatan Blado pada tanggal 08 September 2020. Tujuan dari penelitian ini ialah untuk mengetahui transparansi pengelolaan Alokasi Dana Desa untuk mewujudkan *good governance* di Desa Kalisari Kecamatan Blado, Kabupaten Batang. Dengan adanya pengelolaan Alokasi Dana Desa dapat membuktikan dan menjelaskan tentang perencanaan dan tujuan yang telah di rencanakan oleh Pemerintah Desa dapat berjalan secara transparan, efektif dan efisien. Untuk mengetahui hambatan-hambatan yang timbul dalam pengelolaan Alokasi Dana Desa dan bagaimana solusinya. Metode penelitian tersebut menggunakan metode sosiologi yuridis, pengumpulan data dilakukan dengan pengamatan langsung dilapangan dan melalui wawancara. Teknik analisis data yang dilakukan dalam penelitian ini ialah menggunakan deskriptif kualitatif. Hasil dari riset/penelitian ini menunjukkan bahwa di Desa Kalisari secara bertahap sudah menerapkan prinsip akuntabilitas yang didukung prinsip transparansi, akuntabilitas, partisipasi serta berorientasi. Perencanaan dan pelaksanaan yang di lakukan oleh Pemerintah Desa Kalisari dalam mewujudkan transparansi alokasi dana desa. Dengan mewujudkan transparansi pihak Pemerintah Desa memberikan informasi dengan cara musyawarah mufakat dan melakukan pemasangan baliho, untuk memuat informasi setiap rancangan program yang telah dilaksanakan. Dengan adanya pertanggungjawaban Anggaran Pendapatan dan Belanja Desa (APBDesa) baik secara teknis maupun administrasi sudah baik.

ABSTRAC

The Tranparency In Managing The Allocation Of The Village Funds To Realize A Good Governance (A Case Study in Kalisari Village, Blado District, Batang Regency)

The research was conducted based on the result of the research in Kalisari village, Blado district on 08th September, 2020, which related to the management of the Allocation of Village Funds and the Local Village Budget. The research aims to know the transparency of the allocation of the village fund to realize a good governance in Kalisari village, Blado district, Batang Regency. By doing so, it can prove and explain that the planning and the objectives that have been arranged and planned by the government of the village run in an effective, efficient and obvious manner. Also, the researcher wants to identify the obstcales and the problem solving in managing of the allocation of the village funds.

This research method used sociological juridical method. The technique of collecting data used was direct observation in the field and interviews. Beside, the technique of data analysis used was descriptive qualitative. The results of this research show that Kalisari village had gradually implemented the principles of accountability which is supported by the principles of transparency, accountability, participation and orientation. The planning and the conducting were carried out by the government of Kalisari village in realizing the transparency of the allocation of the village funds. By doing so, the government of the village provides the information by the deliberation in the framing of the billboard that contains of information in each of every program that has been implemented. Thus, the local village budget has been implemented well both both technically and administratively .
