

ABSTRAK

Penelitian ini, yang berjudul “Penyelesaian Kasus Tindak Pidana Kekerasan Dalam Rumah Tangga Di Lingkungan Masyarakat Samin (Studi Kasus Di Desa Klopoduwur, Kecamatan Banjarejo, Kabupaten Blora)” bertujuan untuk mengetahui faktor-faktor yang menimbulkan Kekerasan Dalam Rumah Tangga (KDRT) serta bagaimana penyelesaian tindak pidana KDRT tersebut. Metode penelitian yang digunakan yaitu yuridis empiris, sumber data diperoleh melalui penelitian lapangan (wawancara) dan penelitian pustaka. Analisis yang digunakan adalah deskriptif dengan memadukan hasil penelitian lapangan dengan penelitian pustaka.

Berdasarkan hasil penelitian dapat disimpulkan bahwa faktor-faktor yang menyebabkan terjadinya tindak KDRT di lingkungan masyarakat samin di Desa Klopoduwur diantaranya faktor ekonomi, pernikahan usia dini, dan faktor lain (pernikahan dengan perjodohan). Proses penyelesaian kasus KDRT yang dialami oleh para korban dilakukan dengan cara mediasi dengan model *family and community group conferences* yang melibatkan korban dan pelaku KDRT, pihak keluarga, sesepuh atau tokoh masyarakat di Desa Klopoduuwur, serta kepala desa dan perangkat desa. Para korban KDRT memilih proses penyelesaian tersebut dikarenakan masih adanya rasa cinta kasih kepada para pasangannya sebagai pelaku tindak KDRT.

ABSTRACT

This research "Settlement of Criminal Cases of Domestic Violence in the Samin Community (Case Study in Klopoduwur Village, Banjarejo District, Blora Regency)" aims to determine the factors that cause Domestic Violence (KDRT) and how to resolve them. The research method used is juridical empirical, data sources obtained through field research (interviews) and literature research. The analysis used is descriptive by combining the results of field research with library research.

Based on the results of the study, it can be concluded that the factors that cause domestic violence in the samin community in Klopoduwur village include economic factors, early age marriage, and other factors (arranged marriage). The process of resolving cases of domestic violence experienced by victims is carried out by means of mediation with a family and community group conferences model involving victims and perpetrators of domestic violence, family parties, elders or community leaders in Klopoduuwur Village, as well as village heads and village officials. Victims of domestic violence chose the settlement process because there was still a sense of love for their partners as perpetrators of domestic violence.
