

## ABSTRAK

Mobilitas orang asing di Indonesia, khususnya Wilayah Jawa Tengah sangat banyak dan bermacam-macam. Untuk itu diperlukan pengawasan dan penindakan keimigrasian terhadap orang asing. Kantor Imigrasi mempunyai peran dan fungsi dalam pengawasan dan penindakan terhadap orang asing. Masalah yang diteliti meliputi: (1) Bagaimana tugas dan fungsi kantor imigrasi?; (2) Bagaimana kendala keimigrasian dalam melaksanakan tugas dan fungsinya?; dan (3) Bagaimana upaya keimigrasian dalam melaksanakan tugas dan fungsinya?. Data diperoleh melalui wawancara, dan dokumentasi. Sedangkan proses pengabsahan data menggunakan teknik pemeriksaan keabsahan data triangulasi dengan analisis data melalui kegiatan pengumpulan data, reduksi data, penyajian data, dan kesimpulan atau verifikasi data. Dalam penelitian ini dapat diketahui bahwa (1) Peran Kantor Imigrasi yaitu sebagai koordinator dalam pengkoordinasian, perencanaan, pengendalian program kegiatan pengawasan dan penindakan keimigrasian terhadap orang asing; Pembina kegiatan pengawasan dan penindakan keimigrasian terhadap orang asing; dan Penegak hukum di bidang keimigrasian. (2) Kendala Kantor Imigrasi dalam melaksanakan peran tersebut antara lain kurangnya kualitas dan kuantitas sumber daya manusia para pegawai; dan Anggaran kerja untuk kegiatan pengawasan dan penindakan orang asing tidak aplikatif dengan rencana kerja. Simpulan yang diperoleh dari penelitian ini adalah efektifitas pelaksanaan pengawasan dan penindakan keimigrasian terhadap orang asing oleh Kantor Imigrasi masih kurang. Hal tersebut disebabkan oleh kurangnya kualitas dan kuantitas Sumber Daya Manusia pegawai, serta terbatasnya anggaran. Saran agar lebih mengutamakan dan meningkatkan kedisiplinan, integritas dan kinerja secara optimal dalam melaksanakan peran dan fungsi dalam pelaksanaan pengawasan dan penindakan terhadap orang asing, serta lebih memperhatikan terjaminnya penghormatan terhadap Hak Asasi Manusia.

## ABSTRACT

The mobility of foreigners in Indonesia, especially the Central Java Region is very much and varied. Therefore, it is necessary to supervise and enforce immigration to foreigners. The Immigration Office has a role and function in the supervision and action of foreigners. The issues studied include: (1) How are the duties and functions of the immigration office ?; (2) How are immigration constraints in performing their duties and functions ?; and (3) How is the immigration effort in carrying out its duties and functions ?. Data obtained through interviews, and documentation. While the process of data validation using the technique of examination of data validity triangulation with data analysis through data collection activities, data reduction, data presentation, and conclusion or verification data. In this research, it can be seen that (1) The role of Immigration Office is as coordinator in coordinating, planning, controlling program of supervisory activities and immigration action against foreigners; Establish supervisory activities and immigration actions against foreigners; and law enforcers in the field of immigration. (2) Immigration Office Constraints in performing such roles include lack of quality and quantity of human resources of employees; and Working budgets for surveillance and action of foreigners are not applicable to the work plan. The conclusions obtained from this research is the effectiveness of immigration supervision and action against foreigners by the Immigration Office is still lacking. This is due to the lack of quality and quantity of Human Resources employees, and limited budget. Suggestions to prioritize and improve discipline, integrity and performance optimally in performing roles and functions in the implementation of supervision and action against foreigners, and more attention to the guarantee of respect for human rights.
